About the WRC, ICSSR-

The Indian Council of Social Science Research, an autonomous organization, was established by the Government of India in 1969. It, in turn, established the Western Regional Centre (WRC) with the approval of the Government of Maharashtra in January 1973 in collaboration with the University of Mumbai on the new campus of the University of Mumbai at Vidyanagari.

During the last thirty years, the WRC has grown into a fine and exceedingly useful institution. In fact, it has now been recognized as one of the best and most developed Regional Centres of the ICSSR in the entire country.

The WRC, in pursuance of its aims and objectives, conducts research methodology courses, seminars, and workshops, receives foreign visitors, administers study grant, acquires books and other material on deposit basis, purchases books and journals, maintains a bibliographical unit, operates clearing-cum-documentation services, provides hostel facilities, etc. In addition to the seminars and lectures conducted by foreign social scientists, the WRC organizes and aids seminars, workshops, conferences, lectures and the like in different parts of the western region.

Concept Note -

Research plays an inevitable role in legal discipline. Often described as an instrument of social change, law operates within the society and hence interrelated with almost every other discipline.

This peculiar feature of law, necessitates the holistic interpretation of legal issues in the context of socio economic and political conditions. Legal scholars and professionals including lawyer, judge, academician requires the sound understanding of legal research which is intertwined with analysis, understanding and application. Therefore, scientific knowledge of research methodology becomes indispensable for the comprehensive understanding of legal problems and to find out sustainable solutions to deal with them. However, quality legal research is possible only when researchers undergo systematic training in research methodology. In recognition of the need of reorienting and upgrading the research abilities of research scholars, our college proposes to organize ten days intensive program on legal research methodology with an objective of enhancing research skills of scholars and to provide them a unique opportunity to get themselves trained in methodology of research.

This course intends to discuss some of the very important aspects of legal research methodology and serve as forum for research scholars to interact and discuss them. It intends to make research scholars understand the interdisciplinary context of legal research and impart the training regarding scientific legal research.

Key Objectives of the course –

- 1. To make them understand legal research and its interdisciplinary context by defining the research problem and developing a well-defined methodological framework for their research interest.
- 2. To give exposure to the participants to analytical skill sets for research by apprising them with methods of data collection, processing, interpretation and analysis.
- 3. To enable participants in understanding the basics of qualitative research using contemporary tools and to sensitize them on the ethical aspects of research.
- 4. To train the participants in quality academic writing and to make them understand the significance of publishing in high impact factor peer-reviewed journals.
